

LOCAL APPOINTMENT LIST (Per Maddy Act)
GOVERNMENT CODE SECTION 54972

All members of Boards and Commissions shall be appointed by the Mayor with the approval of the City Council and shall be bona fide residents of the City (except Moreno Valley Utility Business Customers for Utilities Commission). Additionally, unless otherwise permitted or required by ordinance for a particular advisory board or commission, an applicant shall be a registered voter of the City of Moreno Valley. No member shall be an employee of the city during such membership.

The Mayor may, with the approval of the City Council, appoint two alternate members to each board or commission. Alternate members shall have no vote in the proceedings of the board or commission unless a full-term member is absent. In the event of a vacancy, subject to confirmation by the City Council, alternate members shall have priority consideration for assuming the vacated seat for the unexpired portion of the term of the member.

A member shall not serve on more than one City Council Advisory Board or Commission.

EMERGING LEADERS' COUNCIL (9 members, 2 alternates, 25 members-at large) – 2-year terms (Qualifications are high school and college students 14-20 who reside in Moreno Valley. Members-at-large may not be voting members or alternates but may be middle-school age.)

Meets fourth Monday of each month at 6 pm, Conference & Recreation Center, 14075 Frederick St., Moreno Valley, CA

Creates opportunities for public discussion of issues of importance to the community's youth and young adults and communicating those issues to the City Council. Makes recommendations to the City Council regarding youth-related programs, services, and legislation. (Resolution 2021-01)
